# ST. LUKE'S MISSION

Saint Luke's is a warm and nurturing church where all are welcome, known, included and loved and where relationships grow. We worship God together, take care of each other and combine our talents, time and treasures to do God's work in our church and community.

Eligible to serve on the vestry: Only Lay persons, who are confirmed adult communicants in good standing of the church, as defined in General Convention Canon I.17, shall be eligible for election as Vestry members of such Church. (Canon XI, Section 4, Diocese of Virginia)

Eligible to vote at election of vestry members: All adult communicants in good standing, registered in the particular Church in which they offer to vote, shall be entitled to vote at the election of Vestry members. The voting shall be by ballot in person and, unless otherwise provided by the meeting, a majority of the votes cast shall be necessary to a choice. There shall be no voting by proxy. But no election shall be valid unless the participating qualified voters number at least ten percent of the number of active communicants qualified to vote reported for the previous year. (Canon XI, Section 5, Diocese of Virginia)

# ANNUAL MEETING OF ST. LUKE'S, FEBRUARY 12, 2023

Call to Order by Sr Warden Richard McFarland @11:23

The Sr. Warden asked for a motion to approve the minutes of the February 2022 Annual Meeting. Upon motion by Marjy Jones and seconded by Scott Cameron, the January 2022 meeting minutes were approved.

**Nominating Committee Report** - offered by Scott Cameron. The following slate is being proposed: Melissa Bluey, Mark Kauppi, Mike Saperstein, Saro Verghese (for three-year terms), and Chris Weaver (two-year term). Upon motion by Scott Cameron and seconded by Alan Hope, the candidates were submitted for consideration

The Sr. Warden called for nominations from the floor. None were offered.

The Sr. Warden asked for a motion to close nominations. Upon motion by John Young and seconded by Tom Hargrove, the Nominations were closed.

The Sr. Warden asked for a motion to cast a single vote for the entire slate. Upon motion by Tim Staples and seconded by Scott Cameron, the full slate vote was approved.

The Sr. Warden called for a Vote. The slate passed Unanimously. The Sr. Warden and Rector offered Congratulations to the new Vestry members.

The Sr. Warden offered thanks and appreciation to the Nominating Committee and retiring Vestry: Scott Cameron, Lee Gilmore, Reynold Schweickhardt, and Carlo Uchello. Rector Nick Hull presented all 4 with copies of the 1976 Prayer Book which has been used for years during services and are infused with the prayers of the Parish.

**Warden's Report** – offered by outgoing Sr Warden, Richard McFarland. The full report is contained in the 2022 Annual Report Booklet. He stated that the parish is in excellent condition, financially strong with a vibrant congregation and leadership. He was honored to serve as Sr Warden for two years as we moved through the Pandemic and hired a new Rector. He thanked everyone for all the hard work and commitment that it took to get to this point.

**Treasurer's Report** – offered by Alan Hope. The full report is contained in the 2022 Annual Report Booklet. He stated that he appreciates the support of a strong and engaged Finance Committee which meets once a month under the leadership of Paul Johnson. The 2021 Commercial Loan is being paid off over the next 4 years and the Capital Campaign has been completed.

**Message from the Rector** – offered by Rev Nick Hull. It has been an amazing two plus years through the pandemic and including the Search for a new Rector led by Richard McFarland which brought Nick to St Luke's and the birth of his second child. During his Paternity the amazing leadership of the parish showed its strength and depth.

The staff is strong and growing. WE are blessed to have a music director/organist who even writes her own musicals for our youth. New hires include a Communications Coordinator and Education Coordinator. The office continues to run smoothly under the supervision of Sue Bentley. The hiring of a Sextan last year has allowed us to take better care of our physical building and grounds.

We are currently operating as a 1 Clergy Parish which is what the community can support at this time. In the future the hope is to be able to hire an Associate.

While many Episcopal churches are only at 70% of their pre-Covid attendance, St Luke's is exceeding theirs. The Rector is succeeding in his mission to bring new people in, but it will need the welcoming interactions of the entire community to ensure they return and become active members.

**Report on Gift Recipients** – Rev Nick Hull reported that funds in the amount of \$144 from the Rev Lynda Hergenrather Fund will be given to Outreach and funds in the amount of \$921 from the Living Memorial Funds will be given to the Music Instrument Maintenance Fund.

Rev Hull asked if there were any Questions. Seeing none the Rector asked for a motion to adjourn the meeting Upon motion by Scott Cameron and seconded by Tim Staples, the meeting was adjourned at 11:43.

## MESSAGE FROM THE REV. NICK HULL

Friends,

It feels like an eternity ago when I last wrote an annual report for you.

Last year we were getting revved up for our untraditional Lenten Burger of Week Series, and we didn't know how it was going to turn out. We urged you to make gathering and getting to know one another your Lenten discipline, and you did with gusto! The burger nights were more successful than expected, and for me it signaled the beginning of a new and vibrant era in the Church.

Shortly before the annual meeting, we hired Stephanie Kaye as our Communications Minister, and Courtney Jukuri as our Christian Education Minister. I knew this was going to be good, but I didn't realize how good it was going to be. Stephanie didn't own a computer did not have a background in communications when she started, but she took the bull by the horn and quickly made herself an expert at her job. Her innate talent and enthusiasm have given our approach to communications new life, and more importantly she cares enough to bring her good ideas and passion to the Church. Likewise, Courtney jumped into her new position with both feet and she quickly made herself invaluable. Our Education Ministries have been a bright light since I arrived as your priest, and she has helped put that light on a lampstand! Courtney was responsible for bringing Vacation Bible School back last summer, helping keep our parents informed, getting the newest iteration of Journey 2 Adulthood up and running, and welcoming dozens of new families into our program. Adding Stephanie and Courtney to our already amazing staff has been a game changing shift to our identity.

I have seen the staff that have been around blossom in their ministry this past year. Sue Bentley has the organizational might that I lack, but more importantly she cares and sees her position at St. Luke's as a ministry, and not just a job. We wouldn't have a functioning Church without her, and without her creativity in ministry, institutional knowledge and passion, we would not be able to grow nearly as much as we have. In the same way, Kate Weber-Petrova's ministry has grown intensely, because she cares. Our music has always been good, but now it is really good, and the children's pageants and musicals are something unique to our Church. There is a performative element to our music program, but it is not a performance. Foundationally, it is something beautiful given to God from the labors of our members, which we should all strive to do in our ministries. Kristen Manous and Mary Grace McPeak have been a consistent, loving and safe presence in the nursery and are facing the wonderful problem of outgrowing our space. It is not uncommon for ten or more young children to be in the nursery. Finally, I must give Cecil Allan and Andrew Manous the shout out they deserve. It is easy to see broken things, but you almost never notice fixed things. Twice a week Andrew works in our Nave to make sure everything is neat and tidy, and Cecil works most afternoon fixing things before most even notice they were broken.

On a more personal note, I often had to be away as we navigated my wife's cancer diagnosis and treatment. Our entire staff picked up the slack in a big way. They ensured we thrived during this time, and not just got by, and I am beyond thankful for their efforts. Knowing that St. Luke's was in good and loving hands allowed me to put my mind at ease to be present with my wife during this hard time.

I am overwhelmed with gratitude for all of the support my family has received since this past May. Leandra's cancer diagnosis was devastating, and her treatment often did not go as expected. We felt particularly vulnerable as we faced her intensive treatment with two young children at home, and know that the whole of our community was supporting us gave us a tremendous amount of comfort. We are expecting Leandra's treatment to be officially over around Easter this year. I honestly do not know how we would have made it through without the prayers from the Church, love from our Day School, leadership of the

vestry, meals from our community, and the encouragement from all of you. We are most of the way through a season that will take me years to process. I the midst of the fog of the moment I can see clearly that we have landed in a uniquely loving, compassionate and faithful community. Thank you.

This season also has me filled with gratitude for the leadership of the Church. I have been blessed with the privilege of working with amazing Senior Wardens. George Omohundro got me oriented to St. Luke's, Richard McFarland served two years as a partner in ministry and a friend I needed, and Amy Moorman's wisdom, expertise, and dedication kept me and our community healthy in ways you will likely never know. It was Amy's idea to start meeting weekly to check when she became co-senior with Richard McFarland. This has proven to be an effective way of keeping everyone on the same page, a chance to bond, and will likely remain part of the rhythm of St. Luke's. I am thankful for her ministry to the Church, and I will miss hanging out with her every Monday at 4:00!

This past year, we were able to face a host of unexpected challenges with integrity, all of the while welcoming new members to our outpost of the Jesus movement. My hope for this coming year is that we will be reacting less, and we will find ways of strengthening our existing ministries, get creative in implementing new ministries, and have fun while we do it. Something you may have noticed and will see more of is changes to leadership in ministries. Everyone must be valued at St. Luke's, but no one is allowed to be invaluable. Wherever there is a single point of failure in our system, we are going to shake things up and raise up new leadership. This is not because things were going poorly. Quite the opposite, consistency in ministry can create incredible muscle memory in the system, and getting things done can feel like reflex, rather than a challenge. The problem with this is, this sort of consistent leader does not lend itself to flexibility within the system, which we will need further down the line. My goal is to have more than one person who is an expert in any essential ministry. When there is a change in leadership, things will certainly change, and there will likely be mistakes. If the mistakes are of little to no consequence, consign it to oblivion, and let people grow into their ministry. Did you know the bulletin for the Third Sunday after Epiphany was mislabel as the Second Sunday after Epiphany, and no one complained? When I found out, I was glowing with pride.

Once again, I cannot emphasize enough how thankful I am to St. Luke's. This past year has been challenging is ways that I could not have imagined, and I have consistently been met with grace and love from our community. In the midst of all of the difficulty of this year, I am still in awe of how much fun we've had. You are the real deal, and been a light in my life in a very hard year.

### FINANCE REPORT

Paul Johnson, Finance Committee Chair, and Alan Hope, Treasurer

**Status of 2023 Budget**: As of December 31, 2023, the Church had an operating budget deficit of \$55,032. This was expected as the 2023 revised budget had a \$106,826 deficit. However, income increased in December, spending was curtailed, and our reserves covered the deficit.

**Liquid Assets:** As of December 31, the church had \$453,358 in liquid assets. This is a snapshot of these funds as these balances change daily as the church operates. These funds are at Burke and Herbert Bank and are used primarily for:

Church Designated Accounts: \$140,941

These amounts, both restricted and unrestricted, are needed to process liquid parish priorities. Activities such as the altar guild, altar flowers, community outreach, youth group and trips, instrument maintenance fund, etc., have balances and clear regular transactions in this category of funds.

Designated for Capital Expenses: \$150,975. Funds in this category are earmarked for Capital expenses and must be used this way.

Proceeds from BFM Campaign \$58,913 Steeple funds (for BFM): \$89,062 Steeple funds available: \$3,000

Note: The steeple brings in ~\$125,000/year and \$90,000 will be dedicated to BFM through 2026. \$32,000 has been spent on replacement windows this year.

Available for Operating Budget: \$161,443

This consists of current operating funds and any excess funds the church has accumulated from surpluses over the years.

**Reserves:** As of December 31, the church has \$715,458 in Diocesan Investment funds designated for the following:

Endowment Fund \$602,831

Vestry Account \$80,038 (available for operations)

Capital Account \$8,921 Hergenrather Fund \$3,200 Living Memorial Fund \$20,467

**Pledge Growth:** Pledges for 2024 are up from 2023. Total pledge income is expected to be \$560,000, an increase of \$64,500 from this point in 2023.

**2024 Budget Proposal:** At the December 2023 Vestry Meeting, Paul Johnson, Finance Committee Chair, presented a budget that included \$641,510 in spending (see next page). Some key points are:

- 1. The Budget requires the spending of \$8,710 from Liquid Reserves which is much less than what was budgeted in 2023 from reserves.
- 2. This budget fully funds the Christian Education position that was funded from reserve funds last year.
- 3. Budget covers staff Cost of Living Adjustment increases as requested by the Rector.
- 4. The budget covered cost increases the church is experiencing to provide existing programs.
- 5. The Budget was unanimously approved at the December Vestry Meeting.

#### **Church Commercial Loan Status and Plan**

In July 2021, Saint Luke's acquired a commercial loan through the Burke & Herbert (B&H) Bank. This loan allowed us the opportunity to start and complete the Building for Ministry plans for the Parish Hall renovations and the parking lot lighting projects prior to having all the capital saved to complete these projects. The initial loan value was for \$650,000 and was used to pay the incremental bills received from the builder for the parish hall renovations. The monthly required payment is \$4,827.05 in regards to this loan.

In 2022, we paid \$172,092 in Principal and \$15,833 in interest against the loan. The loan is structured as a 5-year loan but with payments amortized over 30 years (after 5 years, either a balloon payment OR loan restructure). The plan from the start was to use the collected proceeds from the Building for Ministry (BfM) capital campaign to pay for the loan, as well as the proceeds from the steeple income, completing all loan payments at the end of the 5-year loan. We intend to use  $\sim$ \$90,000 of cell tower income per year for buying down the loan principle leaving  $\sim$ \$35,000 per year for other emergency capital needs for Saint Luke's Building and Admin needs. In 2023, one principal-only payment was made for \$130,000, in addition to the required monthly payments.

The loan value at the end of 2023 was \$331,142. As of December 31, 2023 there was \$58,913 in the BfM account to be used for future regular payments on the B&H loan. We are currently on track, after completion of the Parish Hall renovation and the Parking Lot Lighting, to pay off of the loan in 5 years.


